## ACHA RECEIVES 2003 BELLAMY AWARD

The Pennsylvania Association of Housing and Redevelopment Agencies (PAHRA) President Joe Kohut presented the 2003 PAHRA Bellamy Award to Frank Aggazio at the 2003 PAHRA Annual Conference Awards Banquet held on November 11, 2003 at Nemacolin Woodlands.

he Bellamy Award recognizes outstanding work by a PAHRA Member and is the highest honor that PAHRA can bestow upon its member agencies. The Award was named as a lasting tribute to one of the PAHRA's Presidents, William C. Bellamy (1968-1970). Mr. Bellamy was the Executive Director of the Altoona Redevelopment Authority and previously, the Executive Director of the York City and York County Redevelopment Authorities. He developed a program for rehabilitation of housing that gained national recognition and was innovative in the design and implementation of projects and programs at both authorities.

The ACHA received the 2003 Bellamy Award for their Home Ownership Program. Also at the Conference, the ACHA was awarded The "Best Practice Award" for the "Resident Construction Training Program".

## MAKING A DIFFERENCE

## Heading for a 3<sup>rd</sup> Straight "High Performer" Year!

he ACHA is on track to winning HUD's prestigious "High Performer" recognition from HUD for the third consecutive year. The federal Quality Housing and Work Responsibility Act ("QHWRA") requires every housing authority to annually certify to its management performance as measured by the Public Housing Assessment System ("PHAS"). By scoring an anticipated score of 92 out of 100 possible points, ACHA will once again exceed HUD's benchmark of 90 and win the highest possible recognition that HUD could give to a housing authority.

PHAS evaluates our administration of the low-income public housing program and is based on objective, uniform and quantifiable standards. The assessment result is our "score" and is a public record for HUD, Congress, local government and members of our communities to evaluate the effectiveness of our management of Low Income Housing.

There are four PHAS performance indicators that housing authorities are assessed on:

- 1. Physical Condition: evaluation of the physical condition of LIPH property through inspections performed by private sector real estate inspectors contracted by HUD.
- 2. Financial Condition: evaluation of ACHA's management of its financial resources through private sector (generally accepted accounting principles) analysis techniques and submission of audited financial statements.
- 3. Management Operations: evaluation of LIPH property management performance in the areas of maintenance, leasing, inspections, applicant screening, lease enforcement and resident service programs.
- 4. Resident Satisfaction Survey: evaluation based on a statistical sample survey of residents, conducted by HUD, to determine resident satisfaction with ACHA's management of LIPH.

Our preliminary PHAS score should be released by the Real Estate Assessment Center before February 1, 2004 and our final score will be available after HUD's review of our audited financial statements.

Frank Aggazio has stated that "receiving the High Performer designation is a commendable recognition of ACHA's teamwork, commitment and efforts to meet HUD's goals and fulfill the ACHA mission."

## A New Look for Uansa Village

his fall, Uansa Village in McKees Rocks took on a new look. Those familiar with the development may not recognize it today since a 4.3 million dollar conversion to a community of 37 new townhomes and a beautiful community center. Uansa Village, originally constructed in 1954 and named after 1930's University of Pittsburgh football All-American Toby Uansa, consisted of 70 row-type family units. In 2001, a complete modernization of Uansa began in an effort to provide quality, up-to-date housing for ACHA residents.

Today, residents enjoy new community amenities including common laundry facilities; landscaping, road and parking improvements; enclosed trash areas; fencing; as well as larger play areas and new equipment for children. Each new townhome includes kitchen and bathroom renovations; upgrades of heating, electrical and plumbing systems; and a private deck or patio.

In addition to the modernization of the entire development, a new community center was constructed to provide on-site management and services for residents. On September 5, 2003, the community center was dedicated to longtime advocate of assisted housing programs and former HUD official Paul LaMarca. Before his death in 2002, LaMarca was a lifelong resident of the McKees Rocks area.

## **Operation Good Neighbor Foundation**

Helping ACHA rid homes of lead-based paint hazards

he affordable housing stock in Allegheny County is often aged. Most of these homes have been painted with lead-based paint. The Environmental Protection Agency has determined that lead is a highly toxic metal that was used for many

years in products and especially paint. Lead may cause a range of health effects, from behavioral problems and learning disabilities, to seizures and death. Children 6 years old and under are most at risk, because their bodies are growing quickly.

Fortunately, Allegheny County Housing Authority recognized that ridding homes of lead-based hazards and eliminating the risk and expense to first-time homebuyers would enhance ACHA's homeownership program.

That's where the **Operation Good Neighbor Foundation** came in. The Three Rivers Communities Inc. is a non-profit affiliate of Allegheny County Housing Authority and the lead agency for ACHA's homeownership initiatives. Three Rivers Communities Inc., applied for

a \$10,000 grant from "Operation Good Neighbor". The **Operation Good Neighbor Foundation** is a 501 c (3) founded by U.S. Senator Rick Santorum. **Operation Good Neighbor Foundation** unites corporations, business and individuals from around the nation to work

directly with grass roots organizations.

Funding from the **Operation Good Neighbor Foundation** paid directly for the risk assessment, clearance testing and steps essential to make three of our new homeowner's houses safe.



"Since I purchased a newer home I assumed that it was lead safe. I would not have known that my home contained LBP if I had not received a call asking me if I would like a free inspection. I had

lead in my front door and garage door. They were completely replaced by beautiful brand new doors. When the job was complete my house was inspected again and I received a written report stating that it is now lead free. ## A New Victory: Groveton Village

n September 16, 2003, the Allegheny County Housing Authority (ACHA) celebrated the grand opening of the new, revitalized Groveton Village. Originally named the "Victory Project" and constructed in 1946 as permanent war housing, Groveton Village had become an undesirable housing development and was in need of significant renovation. The Grand Opening was a celebration for the residents of Groveton as well as many key community leaders involved in the revitalization. Some guest speakers and attendees included former Allegheny County Chief Executive Jim Roddey, Groveton Resident Council President Lynn Bonner, Richard Nemoytin of the U.S. Department of Housing and Development, Developer Ralph Falbo, and Frank Aggazio, the ACHA Executive Director. Longtime Groveton resident Kenneth Watson, who helped lay the bricks of the original Groveton Village in 1942, was honored during the ceremony.



ACHA's goal in modernizing Groveton Village was to create a community that residents would be proud to live in while offering quality housing with modern-day amenities and plenty of living space for families. ACHA also wanted to create a beautiful housing development that was better integrated into the surrounding neighborhoods and accepted by the larger community of Robinson Township.

With the input of residents, ACHA and developer Falbo/ Pennrose came together and created the new Groveton Village through a mixed financing approach. Funds from the

Pennsylvania Housing Finance Agency, the ACHA Capital fund through HUD, Related Capital Company, the Allegheny County Department of Economic Development and the Federal Home Loan Bank of Pittsburgh provided the necessary \$11 million for new construction. Today, the new Groveton Village consists of 69 total units with mix of one, two, three, or four bedroom homes. All units are equipped with ample living and closet space, storage space and washer/dryer hook-ups as well as central air and other modern-day amenities. The landscaping within Groveton Village, coupled with the front patio space and off street parking for each unit, helps to make the community beautiful.

When asked how the residents were adjusting to the new Groveton Village, ACHA Property Manager Gina Kormick stated, "The residents feel very much at home in Groveton and it shows by the way they take pride in their community." Margaret Henderson, a Groveton resident for more than 34 years feels that the new Groveton is a vast improvement in many ways. "Everything is new, clean and well taken care of," she stated. The ACHA is proud to say that the former "Victory Project" of Groveton Village can now be considered a "victory" for residents.

# Community Service Requirement

The Department of Housing and Urban Development re-issued the Community Service Requirement. All residents residing in Low Income Public Housing who are adult members of the household and are not working, enrolled in a self-sufficiency program, disabled, or meets the other exemptions approved by HUD, must perform 8 hours of community service.

All residents affected were notified by the ACHA in July to either request an exemption or begin community service in October. ACHA will provide information on volunteer service bureaus but residents will also have the option to propose and participate in other types of volunteer work. Residents can get "credit" for participating in their child's classroom, volunteering at a church, hospital or senior center, or helping neighborhood groups with special projects.
